


Key cost-side assumptions for FY15 budget

- Administration: ED and no COO; part-time consultant CFO; new assistant shared with Development
- Green & Grow: program concluded, no expenses




Proposed balanced FY15 operating budget (but contains no Greenway capital reserve)



Including cash+in-kind, all sources, not capital expenditures, accrual basis "Other" includes releases and depreciation




FY12 – FY15 operating expenses comparison
