Open Session

Greenway Board Chair Doug Husid called the meeting to order in Open Session with a quorum present via Zoom at 5:37pm.

1. Husid called for a motion to approve the minutes from the March 22nd, 2022 meeting of the Board of Directors. **Upon a motion made by Rebecca Lee and seconded by Bradley Snyder, the minutes were unanimously approved with the correction of the date listed at the top.**
2. Chris Cook informed Doug Husid that Linda See has recused herself from discussion of investment manager for the Conservancy.

3. **Husid called for a motion to go into executive session. Upon a motion made by Rebecca Lee and seconded by Rosalind Gorin, the Board voted unanimously to enter executive session.** Abigale Parker, Alex Rogers Pittman, Audrey Lopez, David Dalena, Eileen Ong, Robert Stigberg and Keelin Caldwell left the meeting.
4. Board is in Executive Session.
5. **Upon a motion made by Karen Johnson and seconded by Matt Conti, the Board voted unanimously to return to public session.** Abigale Parker, Alex Rogers Pittman, Audrey Lopez, David Dalena, Eileen Ong, Robert Stigberg and Keelin Caldwell returned to the meeting.
6. At 6:19, Linda See joined the meeting.
7. Alex Rogers Pittman gave a fundraising update for 2022, highlighting the success of Gala fundraising so far and outlining the opportunities for Board members to be involved in Gala outreach. She also shared the intention to develop a formalized corporate sponsorship program for the Conservancy in 2022.
8. Abigale Parker presented on Horticulture updates, highlighting goals such as leading in the practice of ecological horticulture, earning accreditation as an Arboretum through the American Public Gardens Association, and to continue to increase connection between individuals and corporate groups and nature in the park through volunteer opportunities.
9. Chris Cook provided updates about the Greenway Business Improvement District (BID), explaining that the BID improvement Plan needs to be renewed and emphasizing the importance of the relationship between the Conservancy and the BID. He shared the scope of BID funding support and potential projects they are interested in for the future.
